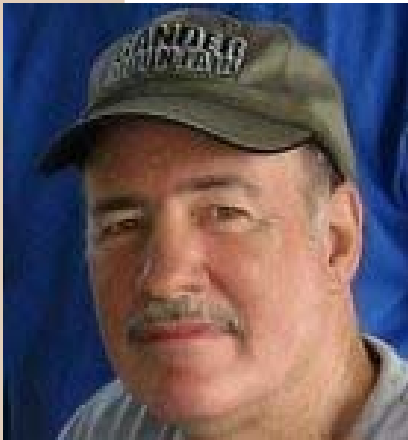

Tech Committee Update

Keeping up with Amateur Radio interests has kept the club Technical Committee busy throughout 2009. With the help of Steve-K9DY, Chris-KQ9Y, Bob-KC9NJM and Dave KB9LOT we have set up, wired up and dug up enough projects to fill a calendar.

Our agenda has taken us to the top of the short tower behind the jail where professional climbers mounted three new VHF/UHF antennas for emergency use. The dual band antenna at 120-feet has proven to be an invaluable simplex link with surrounding counties.

Three new radios and digital interfaces now grace the desktop in the EOC radio room. That was no small feat. It has taken countless hours to run coax, wire up power supplies and customize installation of all radios for a first class radio operation.

Steve and Chris spent a lot of time tuning antennas for the perfect match using their MFJ Analyzers. Ham radio newcomer Richard Burton-KC9QGP helped dig a mast-mounting hole in Brenda Haler's side yard. Brenda-KC9EDL is on the HF airwaves with a multi-band vertical antenna installed last month by Jack, Richard and Steve. Coax leading to the house was buried under ground, then looped up through the attic and dropped into a closet in Brenda's radio room. Sixteen ground radials were added two weeks ago to maximize HF antenna performance.

Earlier this spring Mike Hankins-KC9DSI loaded up Jack's 45-foot tower and moved it to his home in Beech Grove. Rusty Kirts-N9LLP and Richard-KC9QGP made good use of Jack's mast section give-away.

Our thanks to the many volunteers who helped with various stages of special projects this year. I apologize for omitting anyone at this writing.

Amateur Radio Bill

Amateur Radio Bill Passes Senate, Moves to the House

ARRL: On Monday, December 14, — *The Amateur Radio Emergency Communications Enhancement Act of 2009* — ; the bill now goes to the House of Representatives for consideration. Sponsored by Senator Joe Lieberman (ID-CT), and Senator Susan Collins (R-ME), S 1755, if passed, would direct the Department of Homeland Security () to undertake a study on emergency communications. S 1755 points out that "There is a strong Federal interest in the effective performance of Amateur Radio Service stations, and that performance must be given — (A) support at all levels of government; and (B) protection against unreasonable regulation and impediments to the provision of the valuable communications provided by such stations."

Members of the Senate considered S 1755 on December 10. After it passed through Committee, it was placed on the Senate's calendar to be voted on. "We are grateful to Committee Chairman Lieberman and Ranking Member Collins for sponsoring the bill and arranging for its swift consideration and passage by the Senate," said ARRL Chief Executive Officer David Sumner, K1ZZ.

Similar in language to (also called *The Amateur Radio Emergency Communications Enhancement Act of 2009* that was this past April by Representative Sheila Jackson-Lee [D-TX-18]), S 1755 calls on DHS to undertake a study on the uses and capabilities of Amateur Radio Service communications in emergencies and disaster relief and then to submit a report to Congress no more than 180 days after the bill becomes law.
